## Responsibilities and Accountabilities

## **Key Responsibilities**

- To arrange, organise and carry out the planned and unplanned maintenance, repairs, alterations and additions to Bendigo Health Residential Services facilities paint work and general décor as directed.
- Work as part of a team, responsible for the maintenance and repairs to Bendigo Health Residential Services facilities paint work and general décor.
- Assist to co-ordinate contractors to undertake works for the buildings as required.
- Assist in the procurement and purchasing of materials as requested.
- Prioritise all painting works and assist to co-ordinate maintenance work.
- Handle telephone enquiries and to assist to prioritise requests.
- Order and purchase of goods and services in compliance with the purchasing policies and procedures
  of the BHCG.
- Carry our other works in conjunction with other trade staff as directed.
- Participate in team/departmental meetings and other organisation meetings as required.

Employees are required to carry out lawful directions outlined above or delegated to them. The work to be performed is set out in this position description and, where relevant, any professional standards and codes of conduct and ethics issued by the relevant professional association.

## Key Selection Criteria

#### **Essential**

- 1. Qualified Painter (Minimum 5 years after your apprenticeship)
- 2. Demonstrated experience on commercial builds and excellent attention to detail.
- 3. Possess a high level of organisation skills to achieve targets. Be effective with time management and able to prioritise critical issues and have a proactive approach to resolving issues
- 4. Experience and good understanding of Occupational Health & Safety legislation and how it applies to construction projects.

#### Desirable

- 5. Demonstrated experience in Health and Aged Care settings would be an advantage.
- 6. Communication and interpersonal skills to confidently and clearly convey information in a concise and clear manner and is polite and considerate in the dealings with others.
- 7. Punctual, self-motivated and leads by example.
- 8. Professional presentation both written and verbally
