The Position

The Sonographer Trainee will be supported through their postgraduate studies working towards performing the full range of ultrasound examinations to a consistently high standard using a patient focused approach.

A member of the Medical Imaging team the Sonographer Trainee will develop and demonstrate extensive knowledge, experience and competence in diagnostic ultrasound.

Rotation through the general radiography area may be required depending on skill level and staffing requirements.

Responsibilities and Accountabilities

Key Responsibilities

- Operate within the boundaries of the ASAR Sonographer Code of Conduct, and where relevant, MRPB Code of Conduct and Professional Capabilities Standards and ASMIRT Scope of Practice.
- Work towards performing all diagnostic and interventional ultrasound procedures.
- Ensure all examinations are performed efficiently with timing governed by skill level, clinical and patient need.
- Ensure all examinations are presented for reporting with minimum delay and with accurate recording of associated details.
- Act as a mentor or preceptor to less experienced MIT's, trainees, interns and students
- Collaborate with all multidisciplinary team members for the desired outcomes for patients.
- Recognise and report adverse events.
- Conduct yourself in a manner that will not endanger yourself or others.
- Ensure the work environment is safe and report any need for maintenance work.
- Report any unsafe work practices, hazards, near miss incidents and accidents.
- Contribute to safety awareness and promotion by contributing ideas and suggestions.
- Depending on experience and qualifications - perform radiography duties and participate in the Medical Imaging roster including shift, weekend and on-call roster, fulfilling all key responsibilities of the Grade 2 MIT Position Description.

Key Selection Criteria

1. Early diagnostic ultrasound experience
2. Commitment to undertake an ASAR recognised Degree or Postgraduate qualification in Ultrasound
3. Eligibility to register with ASAR as a student sonographer
4. A willingness and ability to learn
5. Ability to interact and communicate with a diverse range of people at all levels

Desirable

6. AHPRA registration Medical Radiation Practitioner
7. Victorian Radiation Use Licence
8. Knowledge of CMBS, imaging rules and requirements
