The Position

Be part of a collaborative multidisciplinary mental health team delivering compassionate, recovery-focused care across inpatient services. The Registered Nurse is responsible for assessing, planning, implementing, and evaluating high-quality nursing care while supporting consumers, carers, and families throughout their treatment journey.

Working alongside Psychiatrists, Medical Officers, Occupational Therapists, Social Workers, and Carer & Consumer representatives, you will contribute to individual recovery plans, promote safe and person-centred care, and provide leadership, mentorship, and support to nursing colleagues and students. This role suits a dedicated mental health professional with strong clinical assessment, communication, and teamwork skills, who is committed to continuous improvement and delivering exceptional patient outcomes.

Responsibilities and Accountabilities

Key Responsibilities

- Assist in the planning, delivery and evaluation of a high standard of nursing care in consultation with the health care team, patients and carers.
- To provide safe customer-focussed patients care in a multidisciplinary environment.
- Provide effective communication so as to include the patients' carers and the multi-disciplinary team in the immediate and ongoing health care.
- Assess the need for and provide health education for patients and their *careers*.
- Refer relevant and important issues to the Senior Nurse on duty or other health care team members.
- Provide leadership and direction and act as a positive role model, providing mentorship/preceptorship to less experienced nurses, including graduate nurses and under-graduate nursing students.
- Undertake (nursing) mental state, social state and physical assessments of patients, which will assist with recommendations for formulation of Individual treatment/recovery plans.
- Ensure the accurate documentation of client records during the shift.

Key Selection Criteria

Essential

1. Post graduate diploma, or working toward, in mental health and/or related field
2. Knowledge and an understanding of the Mental Health and Wellbeing Act 2022 and other relevant legislation and their application to clinical practice
3. Proven ability to liaise and consult with relevant family members, team members and a broad range of health professionals and community agencies
4. Well-developed verbal, written, interpersonal, communication and computer literacy skills and knowledge
5. Demonstrated evidence of and a commitment to ongoing professional development and compliance with all Bendigo Health mandatory training requirements

Desirable

6. Awareness and understanding of the Safewards model and applying this to practice
7. A personal approach which is positive, enthusiastic, friendly and helpful
8. A willingness to learn and flexibility to operate in an environment of change and continuous improvement
