The Position

The AHNM is a leadership position that is responsible for overseeing the provision of safe and efficient care for consumers, staff and visitors to Bendigo Hospital out of hours. It is a fast-paced role that requires critical

thinking and high level decision making. The AHNM works closely with Associate Nurse Unit Managers to ensure timely access to in-patient beds from the different access points into the hospital including the Emergency Department, Operating Theatre and external referrals.

AHNM must be aware of the organisations Key Performance Indicators (KPI's) such as the National Emergency Access Targets (NEAT), Emergency Department Length of Stay (ED LOS) and Elective Surgery Information System (ESIS) so they are able to monitor and influence these KPIs in a positive manner.

Maintaining and understanding the importance of patient flow, problem solving complex clinical issues for speedy resolution is crucial to the position to ensure the highest level of patient care is delivered with the most effective and efficient use of available resources.

Responsibilities and Accountabilities

Key Responsibilities

- In accordance with the Patient Services Manager and Emergency Department, assume responsibility for the appropriate allocation and notification of emergency and elective admissions.
- Work in a professional and respectful manner with staff, consumers, and visitors of Bendigo Health.
- Work closely with the Patient Flow Coordinator, Access and Demand Manager and Director of Nursing to facilitate efficient patient flow.
- Undertake the afterhours management of patient flow into and throughout the organisation that facilitates Bendigo Health achievement of the patient flow key performance indicators outlines by the Department of Health and Human Services (DHHS) and Bendigo Health's patient flow KPI's.
- In collaboration with the Emergency Department (ED) and inpatient units, frequently monitor the length of stay of admitted patients within the ED facilitating timely access to inpatient beds.
- Closely monitor capacity and demand and activate the Hospital Escalation Police as required.
- Ensure that wards/departments provide regular bed status reports through expected channels.
- Contribute to the development and effective implementation of strategies within the Patient Access and Demand plan.
- Coordinate inter-hospital transfers in and out of Bendigo Health, diverting ED presentation by facilitating direct admissions.
- Be the key contact for medical officers to facilitate access to an inpatient bed.
- Provide advice or alternative options to patient admission.
- Monitor afterhours operating theatre availability.
- In consultation with Business Managers and/or their deputies, ensure that units/departments are staffed suitably and that staff levels and mix are appropriate to patient numbers and acuity.
- Facilitate and coordinator the allocation of pool staff to wards.
- Act as a support person for staff and clients during/after critical incidents.
- Assist in acquisition of services, supplies and equipment after hours to ensure appropriate continuity of business.
- Provide initial contact point for management inquiries after hours including liaison and/or appropriate referral with outside groups (media, other hospital etc) in the absence of the Executive (as per BHCG Public Relations Police).
- Document calls made to the Executive.

- Timely dissemination of information to the appropriate stream managers and/or Director of Nursing of any events that have occurred relevant to their stream.
- In the absence of the Chief Executive Officer the position has the delegated authority to make
 decisions to ensure Bendigo Health maintains core business. Will have access to an on call senior
 officer to facilitate decision making.

Key Selection Criteria

Essential

- 1. Current registration as a Registered Nurse with AHPRA (Australia Health Practitioner Registration Agency)
- 2. Provide positive, helpful and enthusiastic leadership in a professional manner.
- 3. Understand, monitor and impact on associated KPI's.
- 4. Extensive relevant post-registration experience in an acute health setting of similar complexity.

Desirable

- 5. Demonstrated ability to communicate effectively with all levels of the organisation
- 6. Demonstrated clinical decision making that allows health care to be delivered in a safe manner to a high standard.
- 7. Ability to work both independently and part of a team to a high standard.
- 8. Demonstrated continual professional development and learning.
