The Position

Reporting directly to the Patient Services Unit Manager the position of Peri Operative Pathway Nurse works collaboratively with Consultants, Anaesthetists, other medical staff and the Patient Services Manager to support the management of patients requiring complex surgery.

The Peri Operative Pathway Nurse is an integral part of the health care service team, providing assessment, management and education to patients pre operatively. The role should encourage and support a philosophy of care, which is patient focused where care is integrated from pre-admission to post discharge.

Responsibilities and Accountabilities

The Perioperative Pathway Nurse will be responsible for fostering strong collaborative relationships across departments at Bendigo Health to support high quality, coordinated surgical care. The Perioperative Pathway Nurse will work closely with physicians, surgical speciality teams and allied health to review and prioritise high risk surgical referrals, optimise patients pre-operatively, and ensure Interventional Suite and In-Patient Units are prepared for safe postoperative management. Throughout the patient journey, the Perioperative Pathway Nurse will conduct thorough assessments and facilitate clear communication between medical and surgical teams, and escalate care when required to prevent deterioration and minimise complications and length of stay. The perioperative Pathway Nurse will also contribute to ongoing service improvement by developing and updating clinical pathways, policies and protocols, and by collecting, analysing and reporting clinical audit data for speciality surgical areas such as colorectal surgery.

Key Responsibilities

- Develop and maintain positive working relationships with other wards/departments throughout Bendigo Health.
- Work with physicians to review, assess, prioritise and manage all referrals identified as high-risk surgical patients by the surgical specialty team and Patient Services Liaison Nurses
- Work with physicians, surgical specialty teams and allied health in assessment and management of preoperative and postoperative care to minimise length of stay, complications and improve overall quality of hospital admission.
- Optimise patients pre-operatively inclusive of referral for pre-operative tests and education.
- Liaise with and ensure inpatient units are prepared for the management of high-risk patients post operatively.
- Escalate management of patients as required.
- Contribute to the development and updating of pathways, policies and protocols to enhance services and care provided to patients.
- Collect, collate and analyse and report clinical audit data for identified speciality surgery e.g. Colorectal.

Key Selection Criteria

Essential

1. Registered Nurse with a minimum of 3 years' experience
2. Demonstrated ability to conduct patient assessments and think critically to assess patient data
3. Demonstrated experience conducting quality audits
4. Exceptional organisational, planning and time management skills
5. Demonstrated ability to work in an environment of change
6. Exceptional communication skills, with a demonstrated ability to engage with a variety of key stakeholders to achieve optimal outcomes for patients.
