#### The Position

The role of the Prostate Cancer Specialist Nurse (PCSN) is to provide specialised evidence-based care and support for men with prostate cancer, and their families, including targeted education; expert assistance navigating the health care system; symptom and side-effect assessment and management; and long-term

survivorship care, with a strong focus on personal agency, health promotion and wellbeing. The PCSN is a primary point of contact for men and their families.

The PCSN is an advanced practice nursing role that incorporates high level clinical service, care coordination, navigation support, clinical leadership, research, education and management to optimise patient outcomes. The PCSN will be actively engaged with patients at any point from diagnosis, through treatment decision making, and for aftercare following treatment(s). The PCSN should be available on an 'as needs' basis during acute treatment periods, with on-treatment care provided by nursing staff funded by local health services to deliver this as standard of care. The role will work closely with urologists, surgeons, medical oncologists, radiation oncologists, nursing, allied health, including continence and sexual health support, and the Urology/ Prostate cancer multidisciplinary team (MDT) to provide care aligned with the Prostate Cancer Optimal Care Pathway (OCP).

The PCSN must undertake the PCFA Prostate Cancer Nursing Course, and specialist health professional training in the delivery of psychosocial care for men with prostate cancer. PCSNs are required to demonstrate the specialist skills, knowledge and capabilities outlined in the PCFA Prostate Cancer Nursing Practice and Capability Framework.

The PCSN position is 0.8 FTE, for a maximum fixed term contract of 36 months. The PCSN will be based within the Cancer Centre, providing a service four days per week 8.30 – 5pm. Operationally, the role will report to the Nurse Unit Manager and to the Prostate Cancer Foundation of Australia (PCFA) nursing manager.

## **Key Responsibilities**

#### **Care Coordination**

Provision and co-ordination of care includes the assessment, planning, implementation, and evaluation of care for men affected by prostate cancer across the survivorship continuum. The PCSN plays a vital role in supporting men and their families at diagnosis, actively following up to provide ongoing survivorship assessment and care.

- Participates in health promotion and advocacy activities that increase knowledge and awareness of prostate cancer.
- Effectively provides safe and effective management of prostate cancer and ensures access to a range
  of services and tailored survivorship interventions to meet the multiple healthcare needs of those
  affected.
- Identifies, validates and prioritises potential and actual survivorship needs, supporting the planning and coordination of care across the survivorship continuum.
- Provides comprehensive and tailored information and education in a co-ordinated manner to achieve optimal health outcomes, reduce distress and promote personal agency.

#### Collaborative and Therapeutic Practice

Men from regional and rural areas are particularly disadvantaged, as they often have to travel significant distances to access healthcare. A key focus of PCSNs is the facilitation of collaborative and therapeutic

relationships with men, partners and their families impacted by prostate cancer, as well as other healthcare professionals.

- Develops therapeutic relationships with those affected by prostate cancer to anticipate and meet care needs across the survivorship continuum.
- Facilitates collaborative relationships between those affected by prostate cancer and the healthcare team.
- Participates as a core member of the multi-disciplinary team in the care and treatment of those affected by prostate cancer.

#### **Professional Practice**

The PCSN is responsible for building and maintaining competency within the PCSN role and for establishing a personal professional development plan in collaboration with their line manager and in alignment with registration requirements.

- Demonstrates understanding of both national and global influences on prostate cancer and how these impact on service delivery at both a patient and organisational policy level.
- Uses appropriate mechanisms for monitoring own performance and competence.
- Practices in accordance with legislative, professional and ethical standards.

#### Critical thinking and Analysis

Critical thinking and analysis require evidenced-based strategies and the use of reflective practice to provide optimal care to men impacted by prostate cancer, as well as their partners and significant others.

- Contributes to quality improvement activities and research aimed at improving outcomes for those affected by prostate cancer.
- Embraces continuing professional development to ensure practice aligns with the best available evidence and emerging developments in prostate cancer care.
- Provides mentorship and peer support to nursing colleagues and others involved in cancer care.

# **Key Selection Criteria**

# Essential minimum requirements

- 1. (a) Registered Nurse with at least five years post registration experience, ideally in prostate cancer, urology or oncology nursing.
  - (b) Post graduate qualification in oncology/urology nursing or equivalent or be willing to work towards
- 2. Demonstrated relevant advanced level of skill in cancer or urological nursing
- 3. Demonstrated effective communication and interpersonal skills in a multidisciplinary context
- 4. Ability to work effectively as a team member

- 5. Proven leadership qualities
- 6. Demonstrated analytical and problem-solving skills
- 7. Evidence of participation in and commitment to quality improvement processes and best practice principles
- 8. Evidence of participation in and commitment to quality improvement processes and best practice principles

### Desirable requirements

- 9. Patient teaching experience
- 10. Competence in the use of relevant information technology
