The Position

All staff at Bendigo Health should have, or aspire to the personal qualities, knowledge and skills as described in the Bendigo Health Staff Capabilities Statement and the Allied Health Grade Level Capabilities: Grade 2 Allied Health Professional. Please refer to links provided to these documents.

The Grade Two Social worker is responsible for the provision of Social Work services within a designated clinical caseload, appropriate to their level of experience and competency. Grade two Social Worker are required to display autonomy of practice, whilst also contributing strongly to the multi-disciplinary team

The purpose of this position is to provide best practice client centred clinical care to clients within the designated caseload in the VPRS team within OPRS at Bendigo Health. There may be opportunities or a requirement for staff to work across other OPRS clinics, dependent on clinical skills and/or department need.

Support client assessment, care planning, and provision of goal-oriented rehabilitation interventions

Contribute to the development of the Outpatient Rehabilitation service, as well as the general Social work department as appropriate in a clinical leadership capacity and in a solution-focussed manner.

OPRS operating hours are 8-6pm, with exception of 5pm on Fridays, with staff working various shifts across these hours. All staff are required to work until 5.30pm one day/week, and part time staff are required to work a Monday and/or Friday.

VICTORIAN PAEDIATRIC REHABILITATION SERVICE (VPRS):

VPRS is a state wide service, offered as an outpatient service which caters for complex rehabilitation needs of children and adolescents recovering from major injury, illness and elective procedures.

The VPRS utilises a child and adolescent-specific, interdisciplinary care model according to best practice; with a focus on the transition from hospital to community and home-based services.

You will work closely with the skilled VPRS team which includes the following disciplines: Physiotherapy, Occupational Therapy, Speech Pathology, Social Work, Exercise Physiology, AHA & the VPRS Regional Coordinator.

- Provide orientation, supervision and training of students, Grade 1 clinicians and Allied Health Assistants as required
- Participate in clinical supervision in accordance with the Allied Health Clinical Supervision protocol
- Demonstrate a commitment to lifelong learning and evidence-based practice through participating in professional development for self and supporting the knowledge and skill development of other professional groups
- Use self-reflection techniques effectively to enhance care provision and interpersonal relationships
- Complete all mandatory and required training and professional development requirements.
- Support management to implement effective recruitment, retention, recognition and development strategies as delegated.

Key Selection Criteria

Essential

- 1. A degree in Social Work (or equivalent) & eligibility for membership of AASW.
- 2. Ability to meet the requirements of the Bendigo Health Allied Health Credentialing and Professional Standards policy (and complete prior to commencement).
- Demonstrated experience in completing comprehensive assessments and delivering time limited interventions for clients with a range of conditions, preferably in a rehabilitation setting.
- 4. Demonstrated ability to set client-centred SMART goals with clients and the multidisciplinary team, and demonstrated ability to facilitate and support client engagement in rehabilitation.
- 5. Demonstrated understanding of evidence-based practice and its application to clinical practice.
- 6. Demonstrated understanding of relevant community services (including NDIS), to ensure appropriate & timely referral to ongoing services & plan for discharge from outpatient rehabilitation as appropriate.
- 7. Demonstrated experience in the clinical supervision of grade 1's and/ or students.

- 8. Demonstrated understanding of quality improvement processes and participation in quality service improvement.
- 9. Demonstrated effective written and oral communication skills, and the ability to build partnerships with other service providers.
- 10. Demonstrated time management skills to manage a caseload, meet deadlines, maintain schedules, set goals/objectives, as required.
