## The Position

### The Bendigo Adult Community Mental Health Team (BACMHT)

The BACMHT is an integrated and multidisciplinary team, delivering 5 day a week community care to persons 25 - 64, providing a case management response to individual patients. Treatment is recovery focused and provided during all stages of illness. The team encompasses a number of different program areas such as Primary Mental Health (PMH) and Perinatal Emotional Health Programs (PEHP), Forensic Clinical Specialist (FCS) and the Mental Health and Advice Response Service (MHARS).

As well as providing proactive treatment and support in the community setting, lead clinicians remain involved in the care, treatment and discharge planning of their patients throughout any inpatient and/or residential admissions.

Based in Bendigo, the BACMHT is one of multiple adult community services offered by Bendigo Health Mental Health Services.

## Responsibilities and Accountabilities

The Clinical Manager is a senior clinician located within the Bendigo Health Mental Health and Wellbeing Service – community clinical setting, and is accountable for the effective clinical leadership for the BACMHT(s). The Clinical Manager demonstrates superior consolidated clinical skills at a proficient level and the focus practice areas of evidence-based suicide intervention practices.

The Clinical Manager role will provide clinical leadership and program guidance, including adherence to the parameters of services, clinical standards and program objectives, and ensuring effective resource utilisation. The role will support the workforce by providing mentoring, particularly to junior clinicians, and supporting the team and other network partners to support collaborative planned treatment responses and system improvements to enhance responses for consumers within the service.

This role actively contributes to the overall team planning to improve consumer and carer experience, through monitoring and evaluating service outcomes, and development and management of changes as appropriate.

## Key Responsibilities

- The Clinical Manager provides evidence based clinical leadership in the assessment, planning and delivery of recovery focused care of patients referred to the BACMHT(s).
- Leads the addressing of priority issues within the BACMHT(s) which are related to tertiary level community-based treatment, case management, support and continuing care services to consumers with more severe forms of mental illness or mental disorder.
- Facilitates the ongoing development of clinical practice in the BACMHT(s).
- Identifies clinical education needs and utilises formal and informal opportunities to improve the team's knowledge and capacity to deliver high quality consumer care.

- Provides mentorship as an expert clinician and positive role modelling through the maintenance of high standards of professional ethics and clinical competence.
- Contributes to the developing and implementing of policy and procedures to provide for appropriate clinical practice in the BACMHT(s).
- Utilises evidence-based practice to define and review clinical standards of practice.
- Leads quality improvement programs that facilitate improved clinical outcomes for consumers.
- Participates in incident review processes and ensures that recommended policies and procedures are implemented and adhered to.
- Provides education and mental health consultation and treatment services to other mental health and wellbeing teams within the service, and facilitates collaborative practice within the multidisciplinary team environment.
- Provides leadership/mentoring to team members, and takes on broader team leadership responsibilities where required.
- Deputises for the Manager BACMHT/PMH, provides leadership/mentoring to team members, and takes on broader team leadership responsibilities where required.

## Key Selection Criteria

### Essential

#### Qualifications / Certificates

1. Bachelor of Nursing, Social Work or Bachelor of Applied Science plus post graduate qualifications in Occupational Therapy
2. Post graduate diploma in mental health and/or related field; or having completed a specialist undergraduate psychiatric nursing program or a specialist post basic course of training which led to registration as a division 3 Nurse
3. Minimum of 5 years full time equivalent post registration experience in Mental Health with experience across a range of settings including psychiatric triage, assessment support and treatment of people with a mental illness and associated complex issues.

#### Specialist Expertise

4. Demonstrated commitment and ability to practice utilising the recovery approach in mental health treatment and support, with a focus on working collaboratively with patients and carers to support progress towards reaching personal recovery goals
5. Demonstrated expert level clinical expertise to initiate and lead evidence-based practice in suicide and mental health assessment, care planning and care delivery to patients with complex mental health needs and suicidal ideation
6. Demonstrated ability to provide expert clinical consultancy, networking and dissemination of key messages across a range of key internal and external stakeholders
7. Demonstrated ability to initiate and lead evidence-based clinical practice development and a commitment to the concept of continuous quality improvement whilst possessing excellent knowledge of Mental Health and Wellbeing Act 2022 and its associated principles
8. Excellent verbal and written communication and interpersonal skills, with ability to engage effectively with a range of consumers, their carers, including those from culturally and linguistically diverse backgrounds

## Desirable

9. Ability to query and extract specific information from databases
