Bendigo Health

With more than 4,500 staff and volunteers and covering an area a quarter of the size of Victoria, Bendigo Health, is an expanding regional health service offering the advantages of city life combined with the beauty and freedom that comes from living in a regional area.

Bendigo Health is a 700 bed service that treats more than 45,000 inpatients, triages more than 65,000 emergency attendees and welcomes more than 1,600 new born babies in a year. In addition more than 15,000 operations are performed in our operating theatres and more than 100,000 occasions of services are provided in our clinics to outpatients.

The organisation provides services in emergency, maternity, women's health, medical imaging, pathology, rehabilitation, community services, residential aged care, psychiatric care, community dental, hospice/palliative care, cardiology, cancer services and renal dialysis to the people of the Loddon Mallee region.

With our main campus based in Bendigo, our services extend throughout the Loddon Mallee with sites in areas such as Mildura, Echuca, Swan Hill, Kyneton and Castlemaine.

Demand on services is increasing rapidly with Bendigo being one of Victoria's fastest growing regional cities.

The Clinical Operations Division

The Clinical Operations Division encompasses acute, allied health, cancer and mental health services. We provide a wide range of general medical, surgical and specialty services including but not limited to; Oncology, Cardiology, Renal, Emergency, Women's and Children's, Critical Care, Specialist Clinics, Cancer Clinics and Mental Health Services. Our Allied Health teams provide a diverse range of programs and person centred care in inpatient, outpatient, community, home and residential care settings.

Within a state-of-the-art hospital, our Ambulatory and Critical Care, Medical Services, Surgical Services and Women's and Children's areas use the latest technologies to provide excellent care. Our world class Cancer Centre uses a multi-disciplinary, integrated approach to treat specific cancers. The Cancer Centre offers medical oncology, radiation oncology, specialist nurses, clinical trials and cancer research, palliative care, and a Cancer Wellness Program.

The Mental Health Service provides psychiatric care and treatment across a large catchment area in Victoria stretching from Swan Hill in the north of the state to Gisborne in the south. Family sensitive practice is central to our models of mental health care and best practice ensures the identification, inclusion and support of families, carers and children.

Each year our onsite Specialist Clinics provide over 100,000 service events, we also see more than 60,000 people in our Emergency Department and welcome around 1700 babies into the world. The Clinical Operations Division assists with the admission of more than 50,000 patients into the hospital each year.

The Emergency Department

The team is part of Bendigo Health's Acute Ambulatory and Critical Care Department. The Emergency Department (ED) sees around 65,000 patients each year, making it one of the busiest emergency departments in regional Victoria. The ED is open 24 hours per day, 365 days per year and is staffed by a dedicated team of professionals including emergency medicine specialist doctors, critical care trained nurses, nurse practitioners specialising in emergency care and physiotherapists with expertise in urgent conditions, supported by technical and clerical staff.

The Position

The Nurse Practitioner role in the Emergency Department at Bendigo Health provides high-level clinical nursing, leadership and governance presence and functions autonomously and collaboratively in an advanced and extended clinical role. They work collaboratively with the entire health care team, to assess, diagnose, treat and manage patient presentations. As a clinical nursing expert, the Nurse Practitioner provides clinical leadership and support to colleagues in the performance of their clinical roles.

Responsibilities and Accountabilities

Key Responsibilities

- AHPRA registration as a Registered Nurse with endorsement as a Nurse Practitioner.
- To provide safe and quality care in line with the Australian Nursing Council (ANC) national competency standards, the Code of Ethics and the Code of Professional Conduct for nurses in Australia and commensurate with level of clinical skills and experience.
- Demonstrate advanced clinical experience in the assessment and treatment of illness and injury and health promotion within own individual scope of practice.
- A thorough knowledge and awareness of all emergency department key performance indicators (KPIs) such as time to treatment, NEAT and ambulance KPIs.
- dynamic practice that incorporates application of high level knowledge and skills in extended practice across stable, unpredictable and complex situations.
- Collaborate with multidisciplinary team members to achieve desired health outcomes for patients.
- Mentor or preceptor staff as appropriate in collaboration with emergency department team
- Demonstrate a commitment to organisational change and quality improvement.
- Accept accountability for own actions and seek guidance from appropriate senior clinical staff when limited by own level of expertise.
- Represent the clinical unit on nominated committees, working groups and projects in collaboration with managers ensuring information is shared with the clinical team.
- Demonstrate an awareness of the financial management framework and budgetary issues for the clinical unit.

Generic Responsibilities

Code of Conduct - The Victorian Government's Code of Conduct is binding on all Bendigo Health staff. Contravention of a provision in the code may constitute misconduct and/ or regarded as a breach of the employee's employment agreement and will be dealt with under the organisations Counselling and Disciplinary Action Policy.

Occupational Health and Safety - Every staff member has the responsibility to take reasonable care of their own health and safety and the safety of others, to cooperate with Bendigo Health's OH&S policies and to participate in appropriate safety education and evaluation activities. All staff are expected to participate in reporting any health, safety and wellbeing issues. Any breach in compliance may result in disciplinary action.

Infection Control - Every staff member has the responsibility to minimise incidents of infection/ cross infection of residents, staff, visitors and the general public. All staff must adhere to the policies and procedures as set out in Bendigo Health's infection control manuals. Any breach in compliance may result in disciplinary action.

Confidentiality - All information concerning Bendigo Health, its patients, clients, residents and staff should remain strictly confidential. Any unauthorised disclosure of such information may result in disciplinary action.

Quality Improvement - Bendigo Health is dedicated to improving the quality and safety of health services by providing care within the following domains of quality: Consumer Participation, Clinical Effectiveness, Effective Workforce and Risk Management. As a result, we apply the concept of the quality cycle for all our quality activities, initiatives and projects thereby ensuring the best possible care and treatment results are achieved. The underlying principle of the cycle is that an activity is not complete until evaluation shows that it has been effective and reached the desired outcome. As a Bendigo Health employee you have a responsibility to participate in and commit to ongoing quality improvement activities using the framework of the NSQHSS (National Safety and Quality Health Service Standards).

Diversity – Each person has a right to high-quality health care and opportunities regardless of diversity factors, which might include aspects such as cultural, ethnic, linguistic, religious background, gender, sexual orientation, age and socio-economic status. Key Selection Criteria

Essential

- 1. AHPRA registration as a Registered Nurse with endorsement as a Nurse Practitioner.
- 2. Advanced clinical experience in the assessment and treatment of illness and injury and health promotion relevant to the Emergency Department and within individual scope of practice in the multidisciplinary environment.
- 3. Provide advanced and autonomous expert care to patients by prescribing medications, ordering and analysing pathology and radiological tests, referring patients to general practitioners and other health professionals
- 4. Advanced interpersonal, communication and negotiation skills (written and verbal) and ability to complete all necessary computer data entry requirements.
- 5. Demonstrated extensive leadership experience.
- 6. Knowledge, understanding and experience in quality improvement, its practical application in meeting patient's needs and quality service delivery and its relationship to strategic development.
- 7. Maintain and develop professional nursing standards and practice ensuring that annual hospital and emergency department competencies are met.
- 8. Sound knowledge of relevant legislation and health regulating acts and legislative obligations.

- 9. Demonstrated understanding of key cultural issues influencing practice, patient relationship and patient need

10. Post graduate qualifications in Emergency or Critical care nursing and recent Emergency Department or Urgent Care experience

Mandatory Requirements

National Police Record Check A current and satisfactory National Police Record Check must be completed by all new staff prior to commencement at Bendigo Health.
