Bendigo Health

With more than 4,500 staff and volunteers and covering an area a quarter of the size of Victoria, Bendigo Health, is an expanding regional health service offering the advantages of city life combined with the beauty and freedom that comes from living in a regional area.

Bendigo Health is a 724 bed service that treats more than 45,000 inpatients, triages more than 65,000 emergency attendees and welcomes more than 1,600 new born babies in a year. In addition more than 15,000 operations are performed in our operating theatres and more than 100,000 occasions of services are provided in our clinics to outpatients.

The organisation provides services in emergency, maternity, women's health, medical imaging, pathology, rehabilitation, community services, residential aged care, psychiatric care, community dental, hospice/palliative care, cardiology, cancer services and renal dialysis to the people of the Loddon Mallee region.

With our main campus based in Bendigo, our services extend throughout the Loddon Mallee with sites in areas such as Mildura, Echuca, Swan Hill, Kyneton and Castlemaine.

Demand on services is increasing rapidly with Bendigo being one of Victoria's fastest growing regional cities.

The Clinical Operations Division

The Clinical Operations Division encompasses acute, allied health, cancer and mental health services. We provide a wide range of general medical, surgical and specialty services including but not limited to; Oncology, Cardiology, Renal, Emergency, Women's and Children's, Critical Care, Specialist Clinics, Cancer Clinics and Mental Health Services. Our Allied Health teams provide a diverse range of programs and person centred care in inpatient, outpatient, community, home and residential care settings.

Within a state-of-the-art hospital, our Ambulatory and Critical Care, Medical Services, Surgical Services and Women's and Children's areas use the latest technologies to provide excellent care. Our world class Cancer Centre uses a multi-disciplinary, integrated approach to treat specific cancers. The Cancer Centre offers medical oncology, radiation oncology, specialist nurses, clinical trials and cancer research, palliative care, and a Cancer Wellness Program.

The Mental Health Service provides psychiatric care and treatment across a large catchment area in Victoria stretching from Swan Hill in the north of the state to Gisborne in the south. Family sensitive practice is central to our models of mental health care and best practice ensures the identification, inclusion and support of families, carers and children.

Each year our onsite Specialist Clinics provide over 100,000 service events, we also see more than 60,000 people in our Emergency Department and welcome around 1700 babies into the world. The Clinical Operations Division assists with the admission of more than 50,000 patients into the hospital each year.

Medical Services

The Medical Services Team at Bendigo Health are an integral part of the health care treating team and sits within the Clinical Operations Division (see above).

The Department of Medicine includes Gastroenterology, Endocrinology, Hospital in the Home, Infectious Diseases, Neurology, Respiratory and General Medicine. Inpatients within these subspecialties are currently integrated to a large extent within General Medicine, with inpatient Respiratory Medicine almost entirely managed by Respiratory Physicians but all others managed by General Physicians with specialist input. There are currently four medical teams each comprising of two Interns/HMOs and a Basic Physician Trainee, who rotates from the Austin Hospital. There is a separate Admitting Team whose role is to assess and manage new admissions and to respond to Emergency Codes with the support of Intensive Care and other parent unit staff.

The General Medical Unit has approximately 90-100 patients at any one time providing both elective and emergency management. The unit enjoys a low turnover of nursing staff, ensuring a reliable and supportive resource.

Neurology, Endocrinology and Respiratory Medicine have their own Clinical Unit Heads/Clinical leads and therefore manage these areas and report directly to the Director of Medicine.

There are separate directorates for Geriatrics and Rehabilitation, Oncology, Cardiology and Renal Medicine. These last other specialties have full functioning teams Monday to Friday and variable out-of-hours cover

that includes the Medical Registrar and HMO's from General Medicine contributing to emergency cover arrangements.

The Position

This position is for a Fractional Specialist in Gastroenterology. Services provided (see schedule for details) will include Outpatient sessions (Medicare Funded, so Provider number required), endoscopy sessions in Upper and lower GI endoscopy; participation on the week day gastroenterology consultation roster and teaching junior doctors and undergraduates from Monash Rural Health School (Monash University)..

As a consultant physician you will be expected to practice within your scope of practice and will be subject to Bendigo Health's Credentialing Committee's jurisdiction whilst working in Bendigo Health. You will report to the Clinical Director of Medical Services.

Key initiatives will include:

- The provision of world class multidisciplinary Gastroenterology services within Bendigo Health
- The development of policies and procedures to guide the delivery of Gastroenterology (with special focus on Hepatology), within Bendigo Health.
- Provide leadership for the development and implementation of standards for compassionate, high quality clinical care of Gastroenterology patients both within, and external to, Bendigo Health.
- Undertaking case reviews and providing advice and recommendations to the Clinical Director, Executive Director, CMO and clinicians on appropriate clinical management of Gastroenterology patients

Responsibilities and Accountabilities

Duties will entail but not be limited to;

- Provision of Specialist Physician services to outpatient clinics as allocated, including the viral Hepatitis services.
- Provision of Gastroenterology/Hepatology services to inpatients as rostered
- Participation in on-call roster may be required and would be negotiated.
- Innovate and transform, in consultation with stakeholders, all aspects of the role in-line with best evidence-based practice and foster a culture of best-practice consistent with the strategic goals.
- Attend and partake in Health Service Committees as appropriate and as directed.
- Provide supervision, mentorship and training support to Junior Medical staff rostered to Medical Services and Units.
- Teaching Medical Students and other nursing/allied health students
- Ensure an adequate level of record keeping and communication.
- Ensure appropriate interaction and service integration with other relevant services, including Medical Services, Surgical Services and Acute Ambulatory and Critical Care.
- Participate actively in developing practical solutions to system deficiencies identified at audit.
- Promote and encourage compliance with College CPD programs.

• Further develop clinical skills consistent with special interests and the needs of the Health Service.

Key Selection Criteria

Qualifications / Certificates

- Fellowship of the Royal Australian and New Zealand College of Physicians or equivalent, and demonstrated subspecialty training in Gastroenterology.
- Current registration as a Specialist in Gastroenterology with the Medical Board of Australia or equivalent in countries with substantially comparable training as assessed by RACP have a RACP interview date
- Current certification with the Conjoint Committee for the Recognition of Training in Gastrointestinal Endoscopy in upper and lower endoscopy.

Specialist Expertise

- Extensive relevant clinical experience in Gastroenterology, with special focus on hepatology
- Demonstrated commitment to teaching with experience in teaching both undergraduate and postgraduate students and other staff
- Advanced communication skills
- The applicant must be able to demonstrate:
 - o Effective interpersonal skills.
 - A commitment to ongoing clinical education.
 - o Demonstrated leadership skills.
 - Knowledge of Clinical Governance as this pertains to Gastroenterology.
- Ability to work as part of a team, as well as to work independently
- Evidence of customer service ethos.
- Awareness of current legislation and policies pertaining to medical practice and the workplace including EEO, Occupational Health and Safety, Public Sector management, Infection Control and access for clients with disabilities.
- Knowledge of legislation relevant to Gastroenterology.
- Demonstrated ability to apply Gastroenterology and Hepatology research to clinical practice.
