The Position

The HITH service manages a diverse inpatient cohort across a broad range of acute medical and specialty conditions. The HITH medical team works closely with referring inpatient specialty teams to facilitate safe patient selection, admission, ongoing management and care within the home environment. Service provision is delivered in a range of settings, including the hospital-based HITH clinic, via telehealth, or in the patient's home.

Historically, HITH patients remained under the medical care of their referring general medical or specialty inpatient teams. The HITH service has recently expanded to establish a dedicated HITH medical unit, which will assume primary responsibility for the clinical care of patients admitted to HITH. The HITH medical team will provide ongoing general medical management throughout the HITH admission, while maintaining close collaboration with referring inpatient and specialty teams to support continuity of care and access to specialty expertise as required.

The medical team is comprised of the Clinical Unit Head/HITH Consultant, HITH Consultants, registrars and Hospital Medical Officer, working in close collaboration with the HITH nursing and specialty teams.

The role of the HITH Registrar is to provide day-to-day clinical management of patients admitted under the HITH unit and undertake relevant duties, under the supervision and direction of the Clinical Unit Head and HITH consultants. The Registrar works closely with HITH nursing staff and inpatient teams to coordinate patient care, and provides supervision, support and mentoring to junior medical staff within the unit. Service provision is delivered in a range of settings, including the hospital-based HITH clinic, via telehealth, or in the patient's home.

The successful candidate will be required to draw up a Professional Development Plan with the Medical Director to be approved by the Physician in Charge of Training for the RACP.

Responsibilities and Accountabilities

Key Responsibilities

- Clinical management of HITH patients and the supervision of, and adequate documentation their medical care.
- Initiate, implement and monitor management of patients under supervision, incorporating the appropriate testing and investigation.
- Thoroughly and promptly correlate and record in the medical record the information obtained from its various sources, in an appropriate and ongoing manner, from the initial assessment, treatment, clinical progress and investigations, and to succinctly record this in discharge summary at the time of discharge.

- Foster rapport and good communications using appropriate language, written or verbal, with the patient and other parties as required; including contact with the referring Medical Practitioner.
- Use technology appropriately, with cost benefit and potential patient benefit and complications considered.
- Appropriately liaise with all staff involved in the care of the patient, including communication and referrals necessary for ongoing care post-discharge.
- Perform certain procedures, under supervision as appropriate.
- Regularly review patient objectives, interpretative, physical and mental status, including the development of communication of a discharge plan from the time of admission.
- Counsel and support patients and their families.
- As a representative of the Hospital and the Medical Profession, present an appearance and demeanour of professionalism at all times.
- Continually update and extend personal medical knowledge and skills, regularly attend Clinical Meetings and remain familiar with current medical literature.
- Participate in Divisional/Department/Unit Quality Improvement activities.
- Participate in teaching and educational activities as required.
- Partake in any BH Research Ethics Committee - approved research studies that may be necessary as part of duties.
- Perform other duties as agreed to and as required on occasions by Medical Administration in relation to cover of other registrars due to illness, bereavement or patient transfer.

Key Selection Criteria

Essential

1. MBBS or equivalent degree with current General Registration with AHPRA.
2. Demonstrated appropriate level experience and skills in assessment and clinical management of patients.
3. Thorough understanding of the relevant legislation pertaining to Medical Officers.
4. Holds an AMC certificate of satisfactory completion of PGY2.

Desirable

5. High level interpersonal and communication skills and the ability to communicate confidently and appropriately with patients and their families and other health professionals.
6. Evidence of on-going professional development to continually update personal medical knowledge and skills.
7. Ability to effectively use organisational skills (incorporating documentation, time management skills, critical thinking and priority setting).
8. Ability to operate in an environment of change.
9. Ability to work as an effective team member in a multi-disciplinary environment as well as independently (under appropriate supervision).
