Bendigo Health

With more than 4,500 staff and volunteers and covering an area a quarter of the size of Victoria, Bendigo Health, is an expanding regional health service offering the advantages of city life combined with the beauty and freedom that comes from living in a regional area.

Bendigo Health is a 700 bed service that treats more than 45,000 inpatients, triages more than 65,000 emergency attendees and welcomes more than 1,600 new born babies in a year. In addition more than 15,000 operations are performed in our operating theatres and more than 100,000 occasions of services are provided in our clinics to outpatients.

The organisation provides services in emergency, maternity, women's health, medical imaging, pathology, rehabilitation, community services, residential aged care, psychiatric care, community dental, hospice/palliative care, cardiology, cancer services and renal dialysis to the people of the Loddon Mallee region.

With our main campus based in Bendigo, our services extend throughout the Loddon Mallee with sites in areas such as Mildura, Echuca, Swan Hill, Kyneton and Castlemaine.

Demand on services is increasing rapidly with Bendigo being one of Victoria's fastest growing regional cities.

The Bendigo Community Palliative Care Service (BCSPCS)

The BCSPCS works with people who have a life limiting illness, their families, carers and the community in promoting and providing choices in quality palliative care. It is a community-based team, which liaises and works in conjunction with other community-based services to provide holistic care including generalist palliative care providers. The service is multi-disciplinary including Nursing, Allied Health, Medical and administration. The service covers the Greater Bendigo and Loddon Shires.

The Position

The Palliative Care Medicine Registrar position is a six-month funded Clinical Foundation (previously Clinical Diploma) position designed for physicians who wish to gain experience in the specialty. It is expected that that the post holder would work towards the Clinical Foundation in Palliative Medicine with the Royal College of Physicians. The post holder will be released to attend the advanced trainee education program online and in Melbourne.

Experience will be gained in the following:

- Working within a multi-disciplinary Community Specialist Palliative Care Service.
- Hospital in-reach through the *Palliative Care at Home* program
- Palliative medicine outpatient clinics

Responsibilities and Accountabilities

Key Responsibilities

- Plan, implement and evaluate patient care in the community palliative care team
- Report to the consultant in palliative medicine and work under their direction
- Supervise, support and direct medical students
- Keep accurate legible & timely medical records
- Coordinate and facilitate allied health services
- Ensure compliance with best practice according to available evidence
- Review the policies and procedures of clinical processes
- Organisational Responsibilities:
 - Participate in team/departmental meetings and other organisational meetings as required
 - Participate in staff development and training as required
 - Maintain accurate records, statistics and reports as needed
 - Ensure timely planned discharge of patients
 - Participate in service development as required

Generic Responsibilities

Code of Conduct - The Victorian Government's Code of Conduct is binding on all Bendigo Health staff. Contravention of a provision in the code may constitute misconduct and/ or regarded as a breach of the employee's employment agreement and will be dealt with under the organisations Counselling and Disciplinary Action Policy.

Key Selection Criteria

Essential

- 1. MBBS or equivalent degree with current General Registration with AHPRA
- 2. At least 3 years post-graduate experience
- 3. Current membership of the College training program
- 4. Demonstrated appropriate level experience and skills in the medical assessment and clinical management of patients.
- 5. Thorough understanding of the relevant legislation pertaining to Medical Officers.

Desirable

- 6. High level interpersonal and communication skills and the ability to communicate confidently and appropriately with patients and their families and other health professionals
- 7. Evidence of on-going professional development to continually update personal medical knowledge and skills
- 8. Ability to effectively use organisational skills (incorporating documentation, time management skills, critical thinking and priority setting)
- 9. Ability to operate in an environment of change.
- 10. Ability to work as an effective team member in a multi-disciplinary environment as well as independently (under appropriate supervision)
