Bendigo Health

With more than 4,500 staff and volunteers and covering an area a quarter of the size of Victoria, Bendigo Health, is an expanding regional health service offering the advantages of city life combined with the beauty and freedom that comes from living in a regional area.

Bendigo Health is a 700 bed service that treats more than 45,000 inpatients, triages more than 65,000 emergency attendees and welcomes more than 1,600 new born babies in a year. In addition more than 15,000 operations are performed in our operating theatres and more than 100,000 occasions of services are provided in our clinics to outpatients.

The organisation provides services in emergency, maternity, women's health, medical imaging, pathology, rehabilitation, community services, residential aged care, psychiatric care, community dental, hospice/palliative care, cardiology, cancer services and renal dialysis to the people of the Loddon Mallee region.

With our main campus based in Bendigo, our services extend throughout the Loddon Mallee with sites in areas such as Mildura, Echuca, Swan Hill, Kyneton and Castlemaine.

Demand on services is increasing rapidly with Bendigo being one of Victoria's fastest growing regional cities.

The Clinical Operations Division

The Clinical Operations Division encompasses acute, allied health, cancer and mental health services. We provide a wide range of general medical, surgical and specialty services including but not limited to; Oncology, Cardiology, Renal, Emergency, Women's and Children's, Critical Care, Specialist Clinics, Cancer Clinics and Mental Health Services. Our Allied Health teams provide a diverse range of programs and person centred care in inpatient, outpatient, community, home and residential care settings.

Within a state-of-the-art hospital, our Ambulatory and Critical Care, Medical Services, Surgical Services and Women's and Children's areas use the latest technologies to provide excellent care. Our world class Cancer Centre uses a multi-disciplinary, integrated approach to treat specific cancers. The Cancer Centre offers medical oncology, radiation oncology, specialist nurses, clinical trials and cancer research, palliative care, and a Cancer Wellness Program.

The Mental Health Service provides psychiatric care and treatment across a large catchment area in Victoria stretching from Swan Hill in the north of the state to Gisborne in the south. Family sensitive practice is central to our models of mental health care and best practice ensures the identification, inclusion and support of families, carers and children.

Each year our onsite Specialist Clinics provide over 100,000 service events, we also see more than 60,000 people in our Emergency Department and welcome around 1700 babies into the world. The Clinical Operations Division assists with the admission of more than 50,000 patients into the hospital each year.

The Medical Services Teams

Medical

The Medical Unit teams provides a wide range of acute medical services for inpatients specialising in respiratory, cardiac, neurological, renal and oncological conditions. It consists of two wards 4A and 5A.

Located on the 4th Floor of the New Bendigo Hospital ward 4A is a 28 bed ward which has been set up to specialise in General Medical, Renal and Stroke patients. A non-geographical Acute Medical Unit model of care has been adopted across both wards 4A and 5A allowing for Acute Medical patients admitted from the Emergency Department to be assessed and managed by consultant led Acute Medical Teams on both wards.

Located on the 5th Floor of the New Bendigo Hospital ward 5A is a 28 bed ward which has been set up to specialise in General Medical, Cardiology and Oncology patients. There is also an additional 3 beds in a complex care room attached to this ward.

Located on the 6th Floor of the New Bendigo Hospital ward 6C is a 20 bed ward which has been set up to specialise in Respiratory Medicine, caring for suspected or COVID-19 positive patients.

Surgical

Located on the fifth floor of the New Bendigo hospital, the Surgical Unit (5B) specialises in a range of conditions related to surgery including the pre and post-operative care of patients. The specialties include minor and major abdominal; hepatobiliary; head and neck; facio-maxillary; urology; reconstructive/plastic; and thoracic surgery.

The Complex Care room provides close monitoring and specialised care for patients with high clinical needs. Up to three patients can be admitted to this area, where a dedicated, experienced surgical nurse will care for them. This initiative has optimised the care the team are able to provide for acutely ill patients and has reduced the demand for high dependency beds in the Intensive Care Unit.

The multi-skilled team of health care professionals of the Surgical Unit aim for the best patient outcomes and a smooth transition from hospital to home, through our close links with community services and other care providers. It is also committed to providing a positive learning environment for nursing, medical and allied health professionals.

The Surgical Unit (6B) at Bendigo Health is a new 15 bed surgical unit, which caters primarily for surgeries in the fields of Urology, General Surgery, and Ear, Nose and throat (ENT) and Plastic Surgery. The model of care will primarily see patients admitted for a short duration typically 24-48 hours with longer planned admissions being the discretion of the NUM/ANUM team. In order to maintain high levels of occupancy the unit will actively pull patients from the Inpatient Units, the Emergency Department and the Short Stay Observation Unit.

Orthopaedics

Located on the 4th Floor of the New Bendigo Hospital ward 4B has 32 beds - a mixture of single and two bed rooms with one 4 bed room. The team includes highly skilled orthopaedic surgeons, orthopaedic nurses and allied health professionals such as physiotherapists and occupational therapists.

The Orthopaedic ward offers care to patients before and after an operation who have suffered injuries to their bones, ligaments, tendons or muscles. The team provides a comprehensive range of surgery and emergency care. Services include:

- Orthopaedic and surgical elective surgery pre/post-operative care
- Orthopaedic trauma cases pre/post-surgery
- Other accident and emergency admission
- Conservative management of some orthopaedic conditions

Care is planned and undertaken by a committed team of health care professionals with an emphasis on the best possible outcomes for patients and their families.

The ward enjoys the services of an orthopaedic/geriatric team who care for elderly fractured necks of femur as well as any elderly patient with multiple co morbidities. The team provides a short term rehabilitation within the ward to enable the total joint replacement patients who require a little extra physio over a period of only a few days. The ward enjoys a very stable nursing staff mix with 5 EFT ANUM and a number of clinical nurse specialist positions all actively engaged in various portfolios directed at improving patient care. After major surgery or trauma, the ward refers patients on to rehabilitation where they are helped to return to their homes and the community.

Rehabilitation

Rehabilitation and Geriatric Medicine is a 64 bed Sub-Acute service (consisting of ward 4C and ward 5C) with an even mix of Inpatient Rehabilitation and Geriatric Evaluation and Management (GEM) beds specialising in Amputee, Stroke, Acquired Brain Injury and Aged Care services.

Ward 4C: Musculoskeletal Rehabilitation (16 beds)

GEM (16 beds)

Ward 5C: Neurological and Stroke Rehabilitation (16 beds)

GEM (16 beds); incorporating up to four Acute Care of the Elderly (ACE) beds

Inpatient Rehabilitation Services:

Within ward 4C and 5C, Bendigo Health provides rehabilitation expertise in musculoskeletal, orthopaedic, amputee, stroke, neurological and acquired brain injury rehabilitation. After illness or injury patients may require assessment and intervention to return to their best possible state of physical functioning. Our rehabilitation program provides multidisciplinary care (medical, nursing, dietetics, exercise physiology, occupational therapy, physiotherapy, social work, and speech pathology). Other specialities within Bendigo Health can be accessed as required during a patient's stay, often delivered within the ward.

Inpatient Geriatric Evaluation and Management (GEM) Services:

The primary goal of GEM is to improve the functioning of patient's with multi-dimensional needs associated with medical conditions related to ageing, such as a tendency to fall, incontinence, reduced mobility and cognitive impairment. Patients may also have psychosocial problems. Treatment aims to maximise both functional ability and living arrangements for older adults. Our GEM program provides multidisciplinary care (medical, nursing, dietetics, exercise physiology, occupational therapy, physiotherapy, social work, and speech pathology). Other specialities within Bendigo Health can be accessed as required during a patient's stay, often delivered within the ward.

The multidisciplinary team works with patients individually in order to obtain the best possible outcomes and to meet patient individual goals. Rehabilitation focuses on patient achievement and empowerment of improving patient abilities. This is achieved with weekly ward rounds and case conferences to monitor patient progress. It is every staff member's responsibility to contribute to patients individual goals and assist with discharge planning process. Therapy sessions incorporates specialty one-on-one and group therapy sessions and hydrotherapy sessions.

The Specialist Palliative Care and Evaluation Unit

The Specialist Palliative Care and Evaluation Unit provides Specialist Palliative Care to patients with a life-threatening illness who are no longer having acute care. In patient care can include – end stage care, symptom relief (including radiotherapy), and respite.

The Evaluation Unit hosts patients admitted for Geriatric Evaluation and Management (GEM) who have chronic or complex conditions associated with aging, cognitive dysfunction, chronic illness or disability. The client group is predominantly, but not limited to older people with a primary treatment goal of maximising health status and optimising living arrangements.

The Transition Care Program which is a community program that has patients admitted for a maximum of 12 weeks with the aim of giving time to maximize independence and ascertain an appropriate discharge destination.

Responsibilities and Accountabilities

Key Responsibilities

- Accept accountability for own actions and seek guidance from senior nursing staff when limited by own level of expertise.
- Practice within policy and procedural guidelines, including comply with health service policy regarding uniform, punctuality, annual Leave and ADO liability.
- Promote and support the mandatory competency framework for the clinical unit ensuring compliance issues are addressed within an agreed timeframe.
- Promote and maintain an environment of teamwork and professionalism.
- Demonstrate an awareness of the financial management framework and budgetary issues for the clinical unit.
- Work within the "Delegations of Authority" consistent with the role.

Generic Responsibilities

- 3. Excellent communication and interpersonal skills with a focus on person centred care
- 4. Clinically sound assessment, problem solving and organisational skills
- 5. Ability to work collaboratively within a team environment and team nursing model
- 6. Computer literacy and/or willingness to develop computer skills
- 7. Flexibility to operate in an environment of change and continuous improvement
- 8. Knowledge of and experience in quality improvement activities
- 9. Commitment to ongoing professional development of self and others

Desirable

- 10. Postgraduate qualification in acute nursing based on your specialty. If no qualification, willingness to undertake relevant postgraduate studies
- 11. Member of professional association
